Art. 7 – Care

The originals of the shoot are the property of the author pursuant to art. 98 law 633/1941 and in accordance with the judgment of the Court of Cassation no. 4094 1980 (Italian laws)

Art. 8- Withdraw

the withdraw must be comunicate with registered mail.

The customer can freely withdraw up to 60 days before the date of the ceremony with right to full refund of the deposit. After this date and up to 15 days before the ceremony, the withdrawal will result in 50% refund of the amount paid. The cancellation made within 15 days prior to the ceremony will entail the right, by the photographer, to claim an additional 10% of the price in the form of lump-sum compensation for loss of earnings

Art. 9 - Dispute resolution clause

All disputes arising from this contract will be referred to the Chamber of Commerce (Monza and Brianza) and resolved in accordance with the Rules of Conciliation adopted by it.

If the parties wish to appeal to the ordinary judicial authority, the court of skills is that of the place of residence or domicile of choice of the consumer, mandatory pursuant to art. 33, paragraph 2, letter. u) of the d. lg. No. 206 of 2005.
